1. If your license is suspended before your scheduled lesson, it is YOUR responsibility to obtain a temporary permit from the Tax Collectors office. YOU MUST HAVE THE TEMPORARY PERMIT WITH YOU AT THE DATE/TIME OF YOUR SCHEDULED APPOINTMENT WITH BCI DRIVING SCHOOLS, OR YOUR APPOINTMENT WILL BE CANCELLED AND YOU WILL BE CHARGED A RESCHEDULING FEE OF \$125.00.

2. Please remember to dress appropriately for the driving appointment. This includes closed toe shoes (no flip flops/sandals), jeans/slacks/trousers (no shorts, skirts, dresses), and shirts/tops with sleeves. Turn off cellphone prior to the start of the lesson.
3. The appointment must be made at the time of registration. Once all paperwork has been completed please see the Customer Service Representative to schedule and confirm your appointment. Payment is due at registration.
4. Your driving appointment will start promptly at the time assigned. If you are late, or fail to show to the appointment, the appointment is forfeited and a \$125 rescheduling fee will apply.
5. Make up sessions will be charged at the rate of \$125 per behind the wheel session. This school will not refund any tuition or part of tuition if school is ready, willing and able to fulfill its part of this contract.
6. **Appointments must be cancelled 48 hours (2 days) in advance to avoid forfeit of lesson.** This agreement constitutes the contract between the school and the student, and no verbal statements will be recognized. Session must be scheduled within 3 months from enrollment, or enrollment fee will be forfeited.
7. **No one will be allowed to attend the session with ANY AMOUNT of ALCOHOL or CONTROLLED SUBSTANCE in his/her body. Attending the course with ANY AMOUNT of ALCOHOL or ILLEGAL DRUG in your body will result in cancellation of lesson and will result in FULL REPAYMENT OF FEES.**
8. Students under the age of 18 may not possess or consume any tobacco products.
